## C. IRWN - Funding Application

An application for planning grant has been submitted to the Tule River IRWN Group for the design of a new water main crossing at the north area of Pixley PUD near the Park Dr. alignment to improve water supply and pressure to the north portion of the community and to improve the potential of providing water services to residences and facilities (potentially the Tulare County Park) north of the District. The Tule River IRWM Group was in agreement with the application. The Pixley PUD will receive a portion of the requested funds, for the purpose of conceptual layout of the crossing and initial communications with Caltrans regarding the potential of a new crossing. The contract of said work is expected in the near future.
