- 2) Infrastructure Planning
 - a) Proposition 84 Project
 - The State has received a formal request for an extension on the Proposition 84 funds. The State has informed the District that the extension is being processed.
 - b) USDA Funding Application
 - The USDA has stated that Pixley PUD will not require interim financing for the USDA portion of the project, however, interim financing will be needed for the State portion of the project due to delays in receiving reimbursement funds.
 - Noise mitigation measures are being incorporated into the construction project for Well 5 (enclosure around the well pump) and Tank Site (sound absorbing blankets at the booster pumps, tank and hydro pneumatic tank).
 - The Engineering Services Agreement has to be resubmitted to be consistent with some specific California requirements for USDA projects. A revised Engineering Services Agreement is submitted for review and approval. The Board had approved the Engineering Services Agreement, pending confirmation of insurance limits by District legal counsel.
 - An updated set of options for rate schedules is submitted for consideration of a Proposition 218 process to ensure sufficient funds to pay the debt service for the USDA Loan and reserves required by the USDA.
 - Recommended Action: Board's pleasure
 - c) IRWN Funding Application
 - The Integrated Regional Water Management (IRWN) Implementation Grant Program, Tulare-Kern Funding Area is receiving funding applications for water related improvements. The Project Development Guidelines and Priorities are attached.
 - It is recommended that a brief funding application is prepared for the design of a new water main crossing at the north area of Pixley PUD near the Park Dr. alignment to improve water supply and pressure to the north portion of the community and to improve the potential of providing water service to residences and facilities (potentially the Tulare County Park) north of the District.
 - A draft application is enclosed.
