- 2) INFRASTRUCTURE PLANNING
 - a) Proposition 84 Project
 - The State has received a formal request for an extension on the Proposition 84 funds. The State has informed the District that the extension is being processed.
 - b) USDA Funding Application
 - The USDA has stated that Pixley PUD will not require interim financing for the USDA portion of the project, however, interim financing will be needed for the State portion of the project due to delays in receiving reimbursement funds.
 - Updated Plans and Specifications are submitted to the District, the State, and USDA for review and approval.
 - An updated Engineering Services Agreement is submitted to the USDA in response to comments.
 - The ability to repay the loan offered by the USDA is pending completion of the Proposition 218 process.
 - Recommended Action: Board's pleasure
 - c) IRWN Funding Application
 - The Integrated Regional Water Management (IRWN) Implementation Grant Program, Tulare-Kern Funding Area is receiving funding applications for water related improvements.
 - An application for planning grant has been submitted to the Tule River IRWM Group for the design of a new water main crossing at the north area of Pixley PUD near the Park Dr. alignment to improve water supply and pressure to the north portion of the community and to improve the potential of providing water services to residences and facilities (potentially the Tulare County Park) north of the District.
