Pixley Elementary School

The Pixley PUD has been contacted by consultants for the Pixley Elementary School regarding a proposed expansion of the school. The details of the

proposed expansion have not yet been received for official review and comment. It has been expressed to the consultants for the school that annexation of the elementary school to the Pixley PUD boundary is recommended.
